PARAMEDIC ACCREDITATION AND SYSTEM ID BADGE (INITIAL)

This checklist is for Paramedic Accreditation and System ID Badge (Initial) for any licensed Paramedic within the State of California who wishes to become accredited with the Santa Clara County EMS Agency. In order for an online application to be accepted and processed, the following items must be submitted by the applicant via the online Credentialing Portal.

The requirements for each item contained in this checklist may be reviewed in *Santa Clara County Prehospital Care Policy #205: Paramedic Accreditation*.

- Register for the Santa Clara County EMS Agency Paramedic Accreditation Examination
- Santa Clara County Paramedic Accreditation Fee of \$150.00 must be paid by credit card only. This fee must be paid before the application will be processed.
- Successfully complete the Santa Clara County Paramedic Accreditation Examination with a score of 85% or greater
- EMS Personnel Application – must be completed and digitally signed via the online Credentialing Portal by the Applicant. All documents contained below must be attached digitally:
 - Attach a digital copy (front and back) of two (2) government issued photo identifications: First time applicants must present two (2) non-expired forms of identification from List A, or one (1) from List A and one (1) from List B. Documentation of these forms of identification must be presented to the EMS Agency.

- Attach a digital copy of completed California Department of Justice (DOJ)/ Federal Bureau of Investigations (FBI) Request for Live Scan Service Receipt Form, reportable to Santa Clara County EMS Agency and EMS Authority

Upon **initial** employment with a Santa Clara County EMS System Provider, attach a digital copy of the certificate of completion for each required self-study course listed below:

- Incident Command System 100 (IS-100)
- Introduction to Standardized Emergency Management System (SEMS)
- Introduction to the National Incident Management System (NIMS IS-700a)
- Hazardous Materials First Responder Operation (FRO)

- Weapons of Mass Destruction Awareness (US DHS Course AWR-160)
- Contact the EMS Agency for completion of the following:
 - In-Person Government Identification Verification
 - Personnel photograph taken by Agency Staff if not on file

Online applications will be processed when all required information is complete, including receipt of background clearance from the Department of Justice and Federal Bureau of Investigation. On-site pick up of credential is not available.
